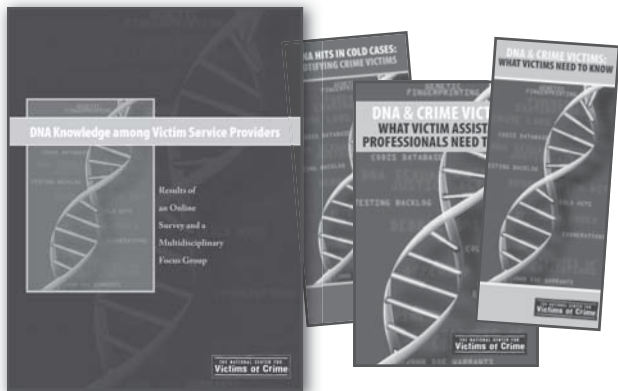


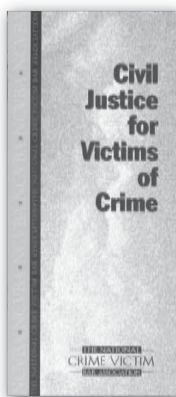

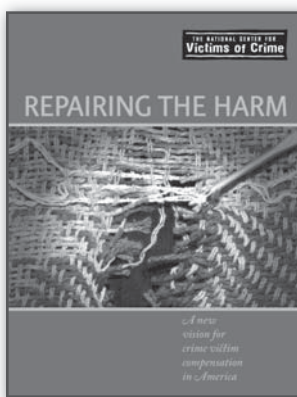
NEW! *DNA and Crime Victims*

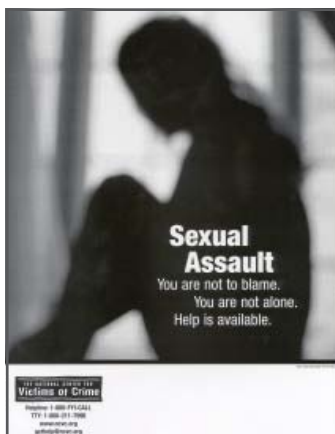


Seeking Parallel Justice

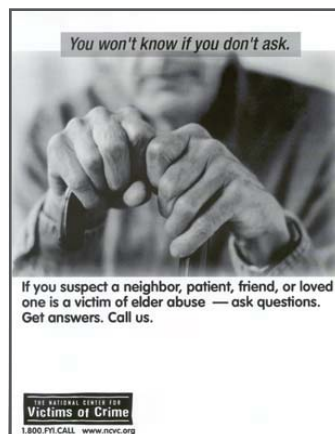

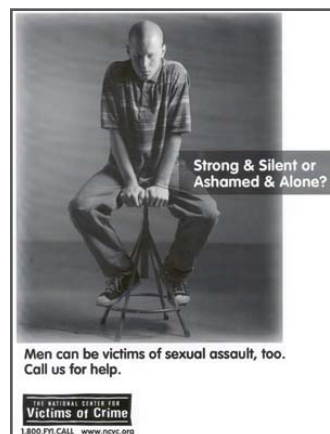

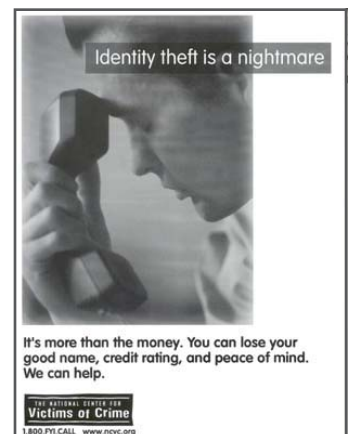
